# 1. Nature of the tasks

The candidate will support the Unit's legislative work, in particular with regard to the Commission's 1 December 2021 proposal on the Digitalisation of cross-border judicial cooperation (<a href="https://ec.europa.eu/info/publications/digitalisation-cross-border-judicial-cooperation">https://ec.europa.eu/info/publications/digitalisation-cross-border-judicial-cooperation</a> en), in particular with regard to:

- assisting in the negotiations process with the co-legislators;
- drafting work related to the foreseen in the Commission's proposal implementing acts;
- interinstitutional relations;
- relations with other Commission departments, legal professionals and other stakeholders;
- carrying out legal/policy research and analysis;
- organising and following-up to meetings (flash reports, meeting minutes, follow-up to action items).

The candidate will also be expected to:

- contribute to the horizontal work of the Unit, in particular by responding to citizens' letters, requests from other stakeholders, preparing replies to: parliamentary questions, inter-service consultations, briefings, speeches, etc.;
- actively participate in meetings with the Commission's departments, the Council, the European Parliament and other stakeholder organisations.

### 2. Main qualifications

a) Eligibility criteria

The following eligibility criteria must be fulfilled by the candidate in order to be seconded to the Commission. Consequently, the candidate who does not fulfil all of these criteria will be automatically eliminated from the selection process.

- <u>Professional experience</u>: at least three years of professional experience in administrative, legal, scientific, technical, advisory or supervisory functions which are equivalent to those of function group AD;
- <u>Seniority</u>: candidates must have at least one year seniority with their employer, that means having worked for an eligible employer as described in Art. 1 of the SNE decision on a permanent or contract basis for at least one year before the secondment;
- <u>Linguistic skills</u>: thorough knowledge of one of the EU languages and a satisfactory knowledge of another EU language to the extent necessary for the performance of the duties. SNE from a third country must produce evidence of a thorough knowledge of one EU language necessary for the performance of his duties.

### b) Selection criteria

#### Diploma

- university degree or
- professional training or professional experience of an equivalent level

in the field(s): law.

### Professional experience

The candidate must possess and demonstrate:

- Relevant professional experience in the area of law in particular, in the area of the law-making process, adjudication and/or negotiations;
- Relevant experience in the justice field and/or experience in relations with the EU institutions will be considered advantageous.

#### Language(s) necessary for the performance of duties

The candidate must possess an excellent command of English, both written and oral, at level C2 or equivalent. Knowledge of French would be considered a plus.

### 3. Submission of applications and selection procedure

Candidates should send their application according to the **Europass CV format** (<a href="http://europass.cedefop.europa.eu/en/documents/curriculum-vitae">http://europass.cedefop.europa.eu/en/documents/curriculum-vitae</a>) in English, French or German only to the Permanent Representation / Diplomatic Mission to the EU of their country, which will forward it to the competent services of the Commission within the deadline fixed by the latter. The CV must mention the date of birth and the nationality of the candidate. Not respecting this procedure or deadlines will automatically invalidate the application.

Candidates are asked not to add any other documents (such as copy of passport, copy of degrees or certificate of professional experience, etc.). If necessary, these will be requested at a later stage. Candidates will be informed of the follow-up of their application by the unit concerned.

## 4. Conditions of the secondment

The secondment will be governed by the **Commission Decision C(2008)6866 of 12/11/2008** laying down rules on the secondment to the Commission of national experts and national experts in professional training (SNE Decision).

The SNE will remain employed and remunerated by his/her employer during the secondment. He/she will equally remain covered by the national social security system.

Unless for cost-free SNE, allowances may be granted by the Commission to SNE fulfilling the conditions provided for in Art. 17 of the SNE decision.

During the secondment, SNE are subject to confidentiality, loyalty and absence of conflict of interest obligations, as provided for in Art. 6 and 7 of the SNE Decision.

If any document is inexact, incomplete or missing, the application may be cancelled.

Staff posted in a **European Union Delegation** are required to have a security clearance (up to SECRET UE/EU SECRET level according to Commission Decision (EU, Euratom) 2015/444 of 13 March 2015, OJ L 72, 17.03.2015, p. 53).

The selected candidate has the obligation to launch the vetting procedure before getting the secondment confirmation.

### 5. Processing of personal data

The selection, secondment and termination of the secondment of a national expert requires the Commission (the competent services of DG HR, DG BUDG, PMO and the DG concerned) to process personal data concerning the person to be seconded, under the responsibility of the Head of Unit of DG HR.DDG.B4. The data processing is subject to the SNE Decision as well as the Regulation (EU) 2018/1725.

Data is kept by the competent services for 10 years after the secondment (2 years for not selected or not seconded experts).

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, rectify or erase your personal data and the right to restrict the processing of your personal data. Where applicable, you also have the right to object to the processing or the right to data portability.
